

## Bylaw Change Comparison Document No. 3

This document contains the full text of the KSA Bylaws that shall be up for consideration at the Special General Meeting to be held on November 29, 2005 at Noon in the Richmond Campus Conference Center, Room 2550, 2<sup>nd</sup> Floor.

**Amended on:** **November 16, 2005** to: 1. add this cover page; 2. to add page numbers to the table of contents in Columns 1, 2 & 3 on Page 2; and to 3. fix some minor typos that appeared in different areas of the document.

**November 20, 2005** to: add specific notice requirements for regulation, budget and policy changes; to add requirements for placing members in bad standing, as opposed to removing them as members. Removing members outright may be contrary to the rights of members as outlined under the College & Institute Act and the Society Act. *No further changes will be made to this document.*

**November 26, 2005** to: 1. correct a [Article 6 \(12\)](#) to change a reference to “these Regulations” to “these Bylaws” and 2. add the requirement under [Article 3\(9\)](#) that a nothing may be discussed at a general meeting that did not appear in the notice of the General Meeting, in order to bring these bylaws into compliance with requirements for General Meetings as specified under the Society Act; and to 3. also add under [Article 8 \(8\)](#), [Article 11 \(3\)](#), [Article 13 \(6\)](#) and [Article 15 \(13\)](#) to clearly state that voting by proxy is not permitted at either Campus Council, Executive Board, Council or at Standing Committees of the Society. [Article 11 \(2\)](#) was also added to clarify that the Executive Board should meet at least three (3) times per month, with the exception of April, August and December, during which months it may meet as it sees fit. *Again, in spite of what was noted on November 20, it is not foreseen that any further changes shall be made to this document.*

- A. Obtaining approximately 350 signatures of students on all four campuses, stating the intent to hold a Special General Meeting on November 29, 2005, as submitted by Christine McLellan to the main office of the Society located on the Surrey Campus;
- B. 25 posters on each campus giving notice to change the bylaws at a Special General, as posted by Noon on the morning of November 15, 2005;
- C. E-mailing the Kwantlen Chronicle asking them to post notice of the meeting in their next issue, should it print before the November 29, 2005 meeting; *and*
- D. E-mailing the First Year Experience Website organizers to ask them to post notice of the meeting on the Kwantlen “what’s happening events” website.
